Position Summary:

The Great Falls Pre-Release Center is a non-profit Community Corrections worksite consisting of three Counseling campuses. The campuses are minimum security and residential in nature, housing closely screened and selected for program acceptance, adult male and female felon offenders during their structured transition program for re-entry into the community. The Centers also operate a Jail Alternative program for adult male/female clients and a Community Service program involving adjudicated males and females.

Under the direction of the Executive Director and Board of Directors the Treatment Services Director will carry out the overall mandate of operating a Community Based Residential Re-Entry Center. The Treatment Services Director is to assist the Executive Director in carrying out the overall treatment program and act as second in command. Some travel may be required.

Key Responsibilities and Duties:

- 1. Regularly meet with Executive Director to coordinate, inform and update on all relevant activities of the Center. At the direction of the Executive Director, provide monthly treatment summary reports for presentation at Board of Director's meetings.
- 2. Participate in monthly Board Committee meetings and contribute agenda items for those meetings. Assist in the preparation of the annual report to the Board of Directors. Assist Executive Director in developing, coordinating and writing grants.

- 3. Assist Executive Director in formulating/meeting budgetary processes. Possess a working knowledge of Center budget to incorporate in program planning. Prepare and fully capable to serve as Executive Director in the latter's absence.
- 4. Insure compliance of case files in accordance with State and Federal regulations. Insure program conformity in terms of prison, Board of Pardons or court ordered mandates. Assign all new Residents to appropriate Correctional Treatment Services staff. Responsible to insure Pre-Release Center meets contract guidelines for Treatment Services and attend meetings as necessary.

- 6. Assist in the hiring procedures of new staff. Responsible for supervising work and arranging on-going training of all Correctional Treatment Specialists and residents assigned.
- 7. Conduct weekly meetings with treatment staff and provide Executive Director with minutes of those meetings as requested. Coordinate agenda for monthly Program Committee meetings and act as primary facilitator at these meetings. Responsible for approving and insuring agenda for monthly Resident meeting. With Executive Director, develop content of staff meetings.
- 8. Review and approve all reports pertaining to residents. Provide oversight of resident expenditures and financial obligations.
- 9. Develop or assist in facilitation of development of expanding Center programing for Residents. Coordinate activities of outside agency program presentations and educational development of Residents. Participate in public relations activities as needed in an ongoing effort to educate the public regarding the Great Falls Pre-Release Services.
- 10. Perform additional duties as assigned.
